### Temple City Newsrack Policy and Regulation Guidelines\*

A newsrack is any self-service or coin operated box, container, storage unit or other dispenser installed, used, or maintained for the display and sale of newspapers or news periodicals.

### Installation

### A newsrack may not:

- be installed onto, over, or within 18 inches of any part of a public roadway
- be in a location that endangers the safety of persons or property, or which interferes with the use of public utilities, public transportation, or other government use
- unreasonably interfere with or impede pedestrian or vehicular traffic, access to any residence or place of business, or the use of poles, posts, traffic signs, traffic signals, hydrants, mailboxes or other permitted objects
- be installed in a location or manner that does not meet the accessibility requirements of the Americans with Disabilities Act or the California Building Code
- be insufficiently illuminated at night as to cause potential hazards
- exceed 4 feet in height, 30 inches in width, or 2 feet in thickness
- be chained, bolted, or otherwise attached to property not owned by the newsrack applicant
- weigh more than 125 pounds when empty

## **Maintenance Standards**

### All permitted newsracks must comply with the following maintenance standards:

- Each newsrack must have the following information affixed or displayed in an easily seen location: applicant name, address, telephone, and email address
- must be in good repair and kept in clean, neat, and attractive condition
- must remain in a vertical position
- must be kept free of advertising not related to the sale or purchase of the material sold within
- may not remain empty in excess of 3 days, materials offered for sale must be the most current edition of the publication
- must be painted regularly and constructed of metal

# **Standards for Materials Sold**

 No material defined as "harmful matter" by the State of California Penal Code section 313 shall be distributed within 100 feet of the entrance to any place catering to minors

#### **Violations and Appeals**

If the City determines a newsrack to be in violation of city code, an order to correct the offending condition will be sent to the applicant and the condition must be corrected within 10 days of the mailing date of the order. If the offending condition is not corrected within 10 days, then this may result in the

removal of the newsrack. If the owner of the offending newsrack cannot be identified then the newsrack will be removed immediately.

Any applicant that disagrees with a finding, determination, notice or action taken by the City may appeal to the city council. The appeal must be requested within 10 days of the receipt of notice or action by filing a letter of appeal with the City Clerk.
