<u>Donna Fong, applicant</u>, asked Community Development Director Forbes to modify condition three in the Conditions of Approval as she intends to landscape the easterly perimeter of the property as opposed to the westerly side of the property.

Community Director Forbes asked Associate Planner Liu if there were any requirements in the Downtown Specific Plan that would require the westerly side of the property to be landscaped.

Associate Planner Liu stated that the Downtown Specific Plan requires five percent of the property to be landscaped but does not specify what area of a property should be landscaped.

Community Development Director Forbes closed the public hearing.

Community Development Director Forbes approved PL 16-351, and adopted the resolution, including a modification to condition three to allow the five percent landscaping to be provided anywhere on the property.
