

**CITY OF TEMPLE CITY  
CITY COUNCIL MEETING ACTIONS**

These are some of the City Council actions from their meeting of January 17, 2023. This is an unofficial record of the City Council meeting. The Minutes, once approved by the City Council at a subsequent meeting, become the official record of the meeting.

At the Special meeting of January 17, 2023, the City Council:

- Met in Closed Session regarding “Labor Negotiation”. There is no reportable action.

At the Regular meeting of January 17, 2023, the City Council:

- Approved the City Council Special and Regular Meeting Minutes of January 3, 2023 and found that the City Council Minutes is exempt from review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guideline 15061(b)(3);
- Received and filed the Parks and Recreation Commission Actions and found that the Commission Actions is exempt from review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guideline 15061(b)(3);
- Adopted Resolution No. 23-5651 authorizing the use of teleconferencing or videoconferencing for Brown Act-covered public meetings of the City Council and City commissions until February 15, 2023 and found that adoption of Resolution 23-5651 is exempt from review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guideline 15061(b)(3);
- Received and filed the Visa Card Report and found that receiving and filing the Visa Card Report is exempt from review under the California Environmental Quality Act (CEQA) per Section 15061(b)(3)
- Adopted Resolution No. 23-5650 approving payment of bills for Fiscal Year 2022-23 and found that adoption of the resolution authorizing the payment of bills is exempt from review under the California Environmental Quality Act (CEQA) per Section 15061(b)(3);
- Authorized the City Manager to amend CDBG-funded program allocations up to 50 percent of the approved allocation as necessary throughout the FY, adopted Resolution 23-5649 establishing the CDBG-funded programs and allocations below for FY 23-24.

The total CDBG Budget for FY 23-24 includes the estimated allocation of \$230,079 and unallocated prior years' funds of \$112,768 for a total of \$342,847; and

i. Housing Rehabilitation Loan & Handyworker Grant Program:	\$250,000
ii. Asbestos Testing and Removal Program:	\$ 47,847
iii. Youth Scholarship Program:	\$ 45,000
<b>Total FY 23-24 CDBG Budget:</b>	<b>\$342,847</b>

Found that approval of the CDBG funds allocation is exempt from review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guideline 15301(d);

- Adopted Resolution No. 23-5648 approving the guidelines for the Permanent Local Housing Allocation (PLHA) Program with added language giving the City Manager authority to approve additional funding up to 20% of the maximum grant amount if a project is found to require additional or unexpected work related to the original scope of work during demolition or construction, and found that the adoption of the City's PLHA Program guidelines are exempt from review under the California Environmental Quality Act (CEQA) per Section 15061(b)(3);
- Approved a public art installation along the Rosemead Boulevard corridor, allocated Art in Public Places funds to cover the project costs, and added an additional \$1,500 to the total cost of the art project to use towards informational placard for each art piece, and found that approval of the public art installation is exempt from review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guideline 15311;
- Received updates from the City Attorney and City Manager; and
- Received Councilmember reports on items separate from the meeting agenda.
