

CITY OF TEMPLE CITY CITY COUNCIL MEETING ACTIONS

These are some of the City Council actions from their meeting of August 15, 2023. This is an unofficial record of the City Council meeting. The Minutes, once approved by the City Council at a subsequent meeting, become the official record of the meeting.

At the Special meeting of August 15, 2023, the City Council:

- Met to discuss one item of potential litigation. City Council received update from staff. No reportable action;
- Met with the labor negotiator regarding Temple City Employee Association, Unrepresented General, Part-Time Employees. No reportable action.

At the Regular meeting of August 15, 2023, the City Council:

- Recognized the Temple City High School Skills USA Group students;
- Received and filed the City Council Special Meeting Minutes of August 1, 2023 and Regular Meeting Minutes of August 1, 2023;
- Received and filed the Transportation and Public Safety Commission regular meeting actions of July 12, 2023;
- Adopted Resolution No. 23-5695 authorizing the payment of bills for Fiscal Year 2022-23;
- Adopted Resolution No. 23-5696 authorizing the payment of bills for Fiscal Year 2023-24;
- Introduced for first reading by title only and waived further reading of Ordinance No. 23-1073, amending Title 2, Chapter 1, Section 2-1-2 “Expenses and Compensation” of the Temple City Municipal Code, and scheduled the second reading of ordinance for September 5, 2023;
- Adopt Resolution No. 23-5690, fixing the City’s contribution under PEMHCA for employees and retired annuitants to the PEMHCA minimum effective October 1, 2023; adopted Resolution No. 23-5691, rescinding Resolution No. 78-1747, the current resolution with the California Public Employees’ Retirement System (CalPERS) regarding the participation of the City of Temple City (City) and stating its contributions to CalPERS’ medical healthcare insurance program, effective October 1, 2023; adopted Resolution No. 23-5692 (Attachment “D”), establishing the side letter agreement between the City and the Temple City Employee Association (TCEA) employee group regarding revisions to health benefits effective October 1, 2023 ; adopted Resolution No. 23-5693 (Attachment “E”), revising the City’s health benefit contributions for full-time non-represented employees effective October 1, 2023; and adopted Resolution No. 23-5694 (Attachment “F”), revising the City’s health benefit contributions for Council members effective October 1, 2023;
- Held a discussion regarding the enforcement of illegal fireworks;
- updates from the City Attorney and City Manager; and
- Received Councilmember reports on items separate from the meeting agenda.
