CITY OF TEMPLE CITY CITY COUNCIL MEETING ACTIONS

These are some of the City Council actions from their meeting of September 5, 2023. This is an unofficial record of the City Council meeting. The Minutes, once approved by the City Council at a subsequent meeting, become the official record of the meeting.

At the Special meeting of September 5, 2023, the City Council:

 Met to discuss one item of potential litigation. City Council gave a unanimous direction to the City prosecutor's office to file a civil action. There will not be a report on the identity of the defendant until after service of the complaint is completed as allowed by the Brown Act. If this matter is returned on a future agenda for Council discussion, it will be listed as ongoing litigation with the full case caption on the agenda.

At the Regular meeting of September 5, 2023, the City Council:

- Recognized the Temple City American Little League 8–10-year-old All Star Team;
- Received and filed the City Council Special and Regular Meeting Minutes of August 15, 2023;
- Received and filed the Transportation and Public Safety Commission regular meeting actions of August 9, 2023;
- Adopted Ordinance No. 23-1073 amending Section 2-1-2 of the Temple City Municipal Code pertaining to City Council Compensation in light of Senate Bill 329
- Approved the final subdivision map for Parcel map No. 83911, authorized the City Clerk to certify Map No. 83911, and find the project exempt from the California Environmental Quality Act pursuant to Section 15301(K)(Existing Facilities) and 15315 (Minor Land Divisions) of the CEQA guideline;
- Approved the final subdivision map for Tract Map for Parcel map No. 82497, authorized the City Clerk to certify Tract Map No. 82497, and find the project exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15268(b)(3) (Ministerial Project – Approval of Final Subdivision Maps) and Section 15332 (In-fill Development Projects) of the California CEQA Guidelines:
- Adopted Resolution No. 23-5698 authorizing the payment of bills for Fiscal Year 2022-23;
- Adopted Resolution No. 23-5699 authorizing the payment of bills for Fiscal Year 2023-24;
- Found Ordinance No. 22-1068 exempt from CEQA per Sections 15305 and 15061(b)(3) of the CEQA Guidelines; introduce for first reading by title only and waive further reading of Ordinance No. 22-1068, scheduled the second reading of Ordinance No. 22-1068 for September 19, 2023, and scheduled the adoption of Resolution 22-5639 for September 19, 2023;
- Pulled the item regarding service agreement with Spectrum to increase bandwidth of internet access for city facilities so staff can further clarify the terms of the service agreement;
- Received and filed the Minutes of the Regular Successor Agency to the Former Temple City Community Redevelopment Agency of August 15, 2023;

- Adopted Resolution No. 23-5700 SA authorizing the payment of Successor Agency to the Former Temple City Community Redevelopment Agency;
- Received updates from the City Attorney and City Manager; and
- Received Councilmember reports on items separate from the meeting agenda.
